Notes : ①The base period of the index is 31 March 2008, and the index referred to March data each year.

②Concerning housing tenure, before 2010, the term "self-owned" means owned by household members and their lineal relatives. From 2010, the meaning is amended to owned by household members who usually live in this house in accordance with the definition of 2010 Population and Housing Census.

③Data referred to 19 general and traffic monitoring stations before 1993. Monitoring stations were replaced with 55 new ambient air quality monitoring stations from 1994 and added to 57 from 1996.

④Using the weighted averages method on the percentages of population served with tap-water and non-tap water to obtain the Percentage of unqualified drinking water: Non-tap water referred to simply tap-water from 2004; in addition, from December 1, 2000, the second phase of tap water quality standards was implemented.

⑤Data before 2000, referred to implementing agencies only. (resource not including data from recycling fund management committees)
