

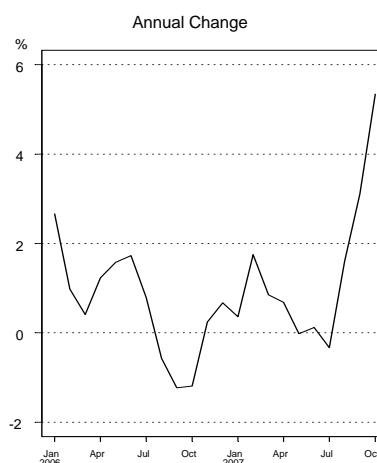
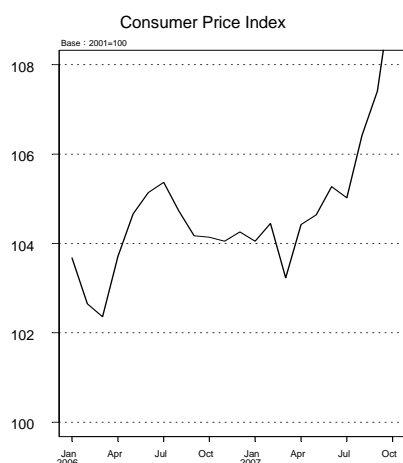
The Price Indices for October 2007

Consumer Price Indices (CPI)

The CPI in October 2007 was 109.70 (2001=100), rising 2.13% from last month, due primarily to prices of Vegetables, Fruits surging 23.50% and 12.32% respectively owing to deferred effect of typhoon damage on Vegetables, especially the widespread and severe impacts from typhoon Krosa, the agriculture losses amounted to 3.8 billion NT dollars, moreover, Garments price advancing 20.90%, Oils price moving up 4.47%, while electricity rate adjusted down since ending of summer, and nursing fee went down after Mid-Autumn Festival.

The CPI in October 2007 jumped 5.34% from the same month of last year, due mainly to Prices of Food going up 14.86%, of which Vegetables rose 78.63%. Commodity prices moved up extensively, such as Chinese Herbal Medicine (56.18%), Eggs (19.06%), Gasoline (11.42%), Edible Oil (11.30%), Dairy Products (11.08%), Meat (9.68%), Bread (9.32%), Fruits (8.25%), Fish & Shellfish (6.01%), Instant Noodles (5.29%), Food away from home (4.88%), Premium of Learning Course (4.54%). Whereas, some electronic products prices went down continuously, such as Mobile Phone (-22.32%), DVD Player/Recorder (-20.88%), Camcorder (-10.99%), Household Stereo (-9.63%), Television (-7.22%), and Personal Computer (-4.73%).

For the first ten months of 2007, the CPI rose 1.35% compared with the same period of last year, as prices of Commodity and Service increased 1.92% and 0.66% respectively. The General Index Excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, up 1.13%.

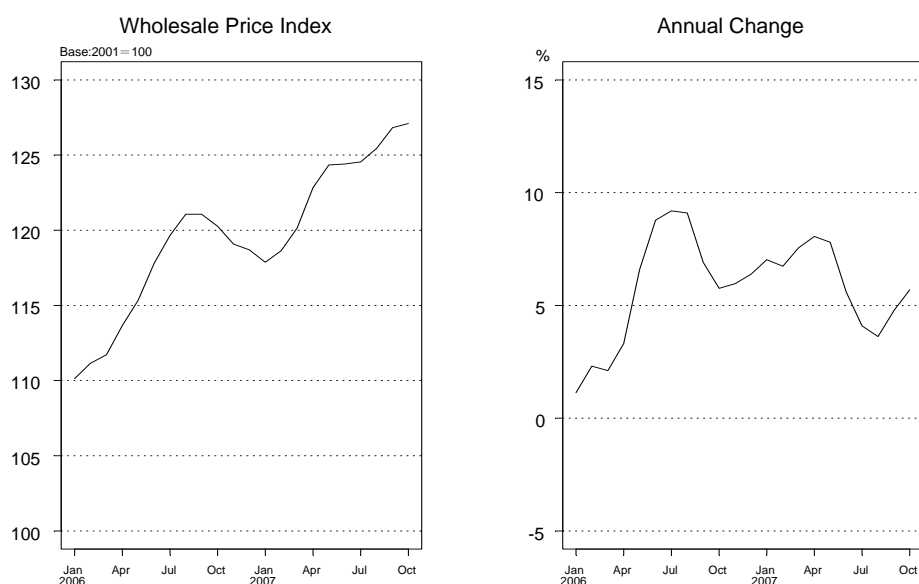


Wholesale Price Indices (WPI)

The WPI in October 2007 was 127.10 (2001=100), rising 0.21% from last month, due primarily to Farm Products, Petroleum & Coal Products and Energy Minerals prices increasing 12.17%, 4.35% and 2.71% respectively.

The WPI in October 2007 advanced 5.69% compared with the same month of last year, due mainly to prices of Energy Minerals, Petroleum & Coal Products and Primary Metal Products moved up 30.88%, 18.89% and 11.52% individually.

For the first ten months of 2007, the WPI went up 6.05% compared with the same period of last year, of which the Import Price Index and Export Price Index up 8.05% and 3.71% separately.
