

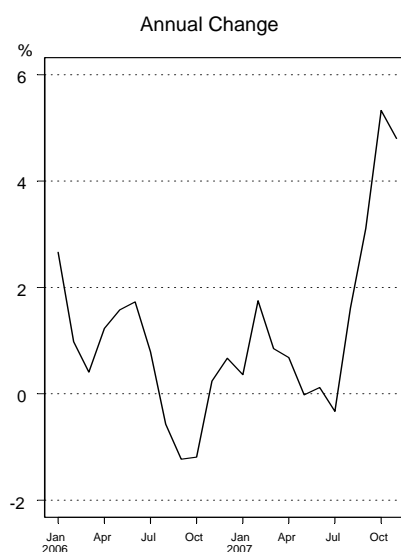
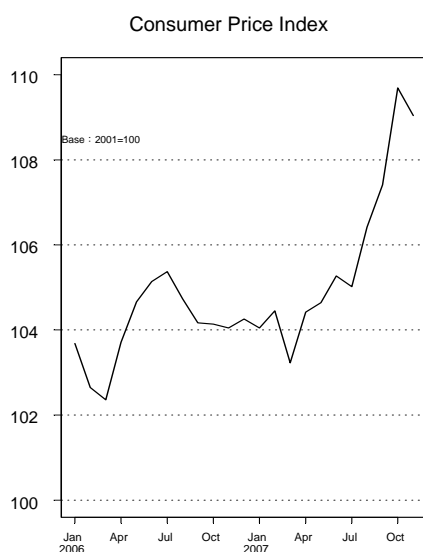
## The Price Indices for November 2007

### Consumer Price Indices (CPI)

The CPI in November 2007 was 109.04 (2001=100), down 0.59% from last month, of which Vegetables prices declined 18.28%, whereas Oils price moved up 2.90% continuously, and Clothing price went up 1.24% for new winter clothing became available in the market.

The annual change rate for CPI in November 2007 hit 4.80%. Prices of Food increased 12.81%, where Vegetables rose 53.00%, Eggs up 34.86%, Fruits up 13.56%, Dairy Products up 11.69%, Meat up 8.43%, Fish & Shellfish up 7.55%. Transportation & Communication prices advanced 4.18%, due mainly prices of Oils jumped 15.91% and Taxi fees raised 12.01%. Medicines & Medical Care prices went up 4.98%, due primarily to shortage of Chinese Herbal Medicine. Some electronic products prices went down continuously. The General Index Excluding Fruits, Vegetables increased 2.88%, The General Index Excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, moved up 2.36%.

For the first eleven months of 2007, the CPI rose 1.66% compared with the same period of last year, where Commodity and Service prices increased 2.48% and 0.67% respectively. The core CPI went up 1.25%.

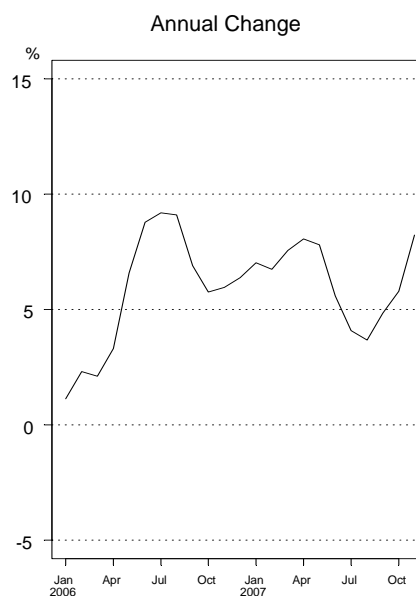
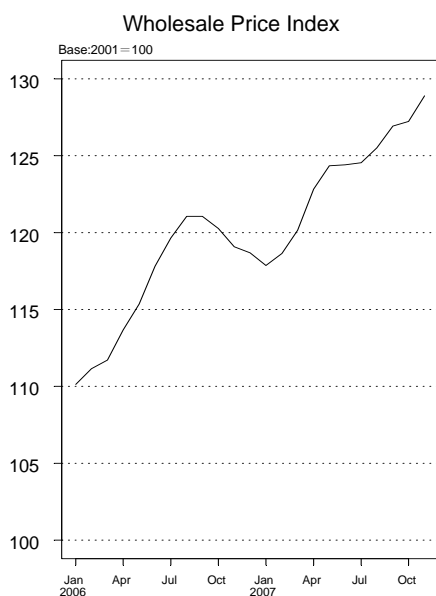


## Wholesale Price Indices (WPI)

The WPI in November 2007 was 128.88 (2001=100), advanced 1.30% from last month, due primarily to Energy Minerals, Petroleum & Coal Products and Chemicals prices increased 11.61%, 4.07% and 1.57% respectively.

The WPI in November 2007 rose 8.23% compared with the same month of last year, due mainly to prices of Energy Minerals, Petroleum & Coal Products and Primary Metal Products moved up 49.87%, 26.68% and 11.17% individually.

For the first eleven months of 2007, the WPI increased 6.27% compared with the same period of last year, of which the Import Price Index and Export Price Index up 8.52% and 3.62% separately.
