

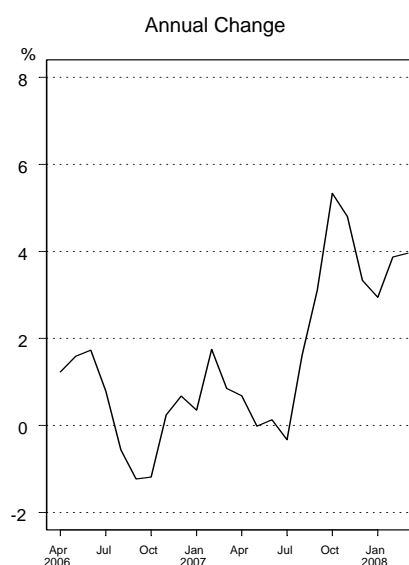
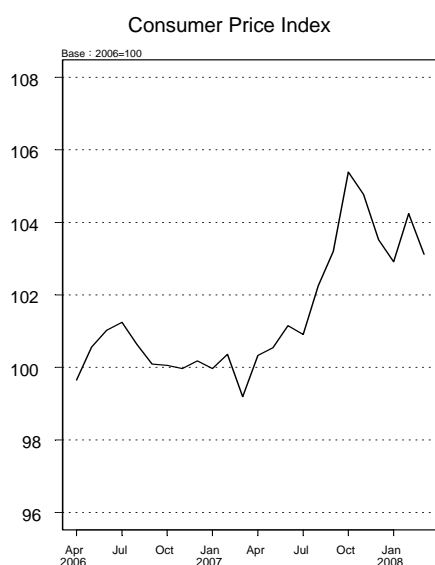
The Price Indices for March 2008

Consumer Price Indices (CPI)

The CPI in March 2008 was 103.12 (2006=100), fell 1.07% from previous month. Due primarily to Vegetables and Fruits prices declined 16.60% and 5.69% respectively, meanwhile, Household Keeping Services fees and Foreign Package Tours fees moved down accompanying by end of the Lunar New Year, whereas prices of Food Away from Home and Cereals & Cereal Products went up for reflecting costs. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, went down 0.61%.

The annual change rate for CPI in March 2008 was 3.96%. Prices of Food increased 9.33%, of which Eggs up 38.25%, Edible Oil up 26.02%, Dairy Products up 14.74%, Fruits, Meat and Cereals & Cereal Products advanced 13.45%, 12.86% and 11.57% separately, Fish & Shellfish up 9.22%, and Food Away from Home up 7.60%. Transportation & Communication prices rose 3.86%, due mainly to prices of Fuels & Lubricants up 14.47% and Taxi fees raised 12.23%. Medicines & Medical Care prices went up 4.21%. The core CPI moved up 3.07%.

For the first quarter of 2008, the CPI moved up 3.59% compared with the same period of previous year, as prices of Commodity and Service rose 5.40% and 1.85% separately. The core CPI went up 2.79%.

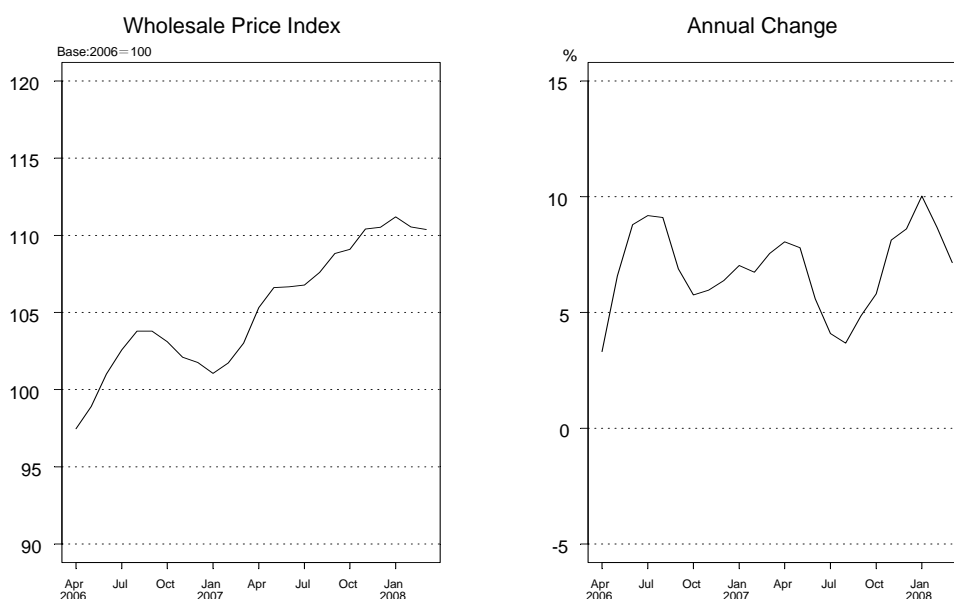


Wholesale Price Indices (WPI)

The WPI in March 2008 was 110.38 (2006=100), decreased 0.14% from previous month, due mainly to 3.30% appreciation of Taiwan Dollar to U.S. Dollar. Besides, prices of Computer, Electronic and Optical Products (fell 2.42%), Electronic Parts and Components (fell 2.31%) and Chemical Material (fell 0.61%) went down, while Basic Metal price rose 4.27%.

The WPI in March 2008 increased 7.15% from the same month of previous year, due mainly to prices of Crude Petroleum and Natural Gas, Petroleum & Coal Products and Basic Metal advanced 49.84%, 28.65%, and 16.83% individually, where as Taiwan Dollar to U.S. Dollar appreciated 7.90%.

For the first quarter of 2008, the WPI moved up 8.61% compared with the same period of previous year, of which the Import and Export Price Index rose 14.38% and 0.11% separately.
