GDP: Advance Estimate of 2019Q2

<u>July 31, 2019</u>. Based on the advance estimate by DGBAS, the real gross domestic product (GDP) grew by 4.68% on a quarter-on-quarter seasonally-adjusted annualized basis (saar) and 2.41% on a year-on-year basis (yoy) in 2019Q2.

Explanation: yoy, saqr, and saar are abbreviated from "year-on-year", "seasonally adjusted quarterly rates", and "seasonally adjusted annualized rates", respectively.

Real private final consumption expanded by 1.57%(yoy) in 2019Q2, higher than the 1.32% growth in the previous quarter, mainly reflecting the sales growth of cars and electric scooters, partly offset by a decrease in sales of information and communications equipment, and the slump in financial services.

Real gross capital formation grew by 6.04%(yoy), following the 6.90% growth in the first quarter, primarily due to the increase in machinery and equipments investment as well as transport equipments.

In addition, real exports of goods and services grew by 4.11%(yoy), stronger than the 0.97% growth in the previous quarter, mainly driven by the foreign strong demand for information, communication and audio-video, as well as refined petroleum products. Imports also increased by 3.69%(yoy).
